5. Those who are Trustees for the purpose and declares that founder (**SMT.SEEMA KUMARI**) will continue to be the Executive Trustee of the Trust and one of the Trustee for his life time.
6. Object of the Trust :-The object of the Trust are to:-
  - 6.1 Establish,run,develop and management of Hospitals, Medical School, Bachelor of Education and colleges, Pharmacy and dental colleges, nursing institutions, dispensaries,meternity homes,technical or non technical educational institutes such as Engineering/Polytechnic Soft ware colleges,management institutes,child or woman welfare centres and such similar institutions in India for the benefit and use of the general public.
  - 6.2 Establish, Run,develop and management, assist and support schools,Colleges.libraries,reading rooms. laboratories, re search and other institutions of the like nature in India for the development and advancement of education and diffusion of knowledge amongst the public in general.
  - 6.3 Establish, run, develop and management studentship scholarship and render other kind of Aid to studends include supply of books, stipends, medals and other incentives to study without any distinction as to caste colour race creed or sex.
  - 6.4 Promote, establish, run and manage institutions for the promotion of science and technology, management, literature, music, drama and fine arts in India for the benefit of the public in general.
  - 6.5 Establish, run, maintain and manage for the establishment and / or maintenance of Park, gardens, gymnasium, sports clubs, dharamshalas and rest houses for use by public in general.
  - 6.6 Establish, run, maintain or manage homes for the aged,or manages or other establishments for the relieve and help to the poor, needy and destitute people,widows and aged persons.

- 6.7 Grant relief and assistance to the needy victims during natural calamities such as famine earthquake flood, fire pestilences etc. and to give assistance to institutions establishment or persons engaged in such relief work.
- 6.8 Establish, run maintain or manage institutions or centres for the physically, handicapped and disabled or mentally retired persons and provide them education, food, clothing or other help.
- 6.9 Organize or promote programmes training in social work as and when required and also to study and analyse Govt. Plan, Policies and social problems requiring urgent intervention through surveys, research and evaluation in such manner as may be considered necessary.
- 6.10 Promote or join the promoting or conduct under take or participate in national and international exhibition, museums, seminars, conferences and conventions.
- 6.11 Establish, Run, Maintain or Manage Institutions, programmes or centres for:-  
 Promotions and expansion of Handicrafts.  
 Welfare and protection of Consumers right.  
 Self help group of men and women for their developments and social economic change. check of appreciates against women and children Eradication of child labour problem and rehabilitation or bonded labour.
- 6.12 Promote or organise or implement activities for the promotion of horticulturs social forestry and forest expansion and to promote the activitives to save the environment from pollution.
- 6.13 Make efforts for information dissemination. R&D to expedite the non conventional source of energy.
- 6.14 Promote and execute activities like sanitation water supply, rural health, construction of roads and other for rural reconstruction whenever necessary.

7 **POWER OF FOUNDER:-**

1. Founder (Settler) shall appoint any employee i.e. Manager, Supervisor, Legal Advisor and Legal Assistant, Accountant, Cashier, Peon Chowkidar etc. He also has powers to terminate the services of any staff as he may be fit and proper for the benefit of the Trust.
2. During the life time of the founder (Settler) he can appoint his nominee and after his death the legal heir will enjoy all the rights of the familiar as presently the founder is enjoying the process of the nomination or successor shall continue fill the working of the trust.
3. The Founder (Settler) Smt. Seema Kumari will be the absolute incharge of the trust and will exercise all the Discretionary and sovereign powers.
8. It is hereby declared that no part of the Trust property or its income shall be applied for any purpose other than the objects of Trust as understood under The Income Tax Act for the time being in force and the surplus funds if any of the Trust shall be invested as per the provided the Income Tax Act.
9. The Number of Trustees shall not be less than three and not more than seven. The Trustees shall be trustees for their life time but any Trustees may resign by giving in writing to the co-Trustees. Appointment of Trustees (s) shall be only with the final approval of settler/his Nominee(s) or the successor(s)
10. General Management and control of Trust Properties and its affairs shall be vested Trustees and the Trustees shall have power to do all such acts as may be considered necessary for the benefit of the Trust and management of its properties and affairs veto power shall always remain with settler, nominees or the successor (s)
11. All the trustees (including Executive Trustee/Founder) shall from the BORD of TRUSTEES and all the decision shall be taken in the meeting of Board of Trustees called from time to time. Without Prejudice to any of the power that the trustees may have under any for the time being in force or to their general power for management, the Trustees shall have the following powers also:-

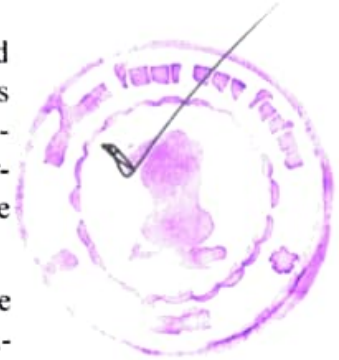
- a. To manage the Trust Fund. Trust Property and other affairs relating to Trust and to do all acts, deeds and things necessary for the preservation maintenance and management thereof and the affairs relating there to or connected therewith, including the making of Rules and Regulations from time to time.
- b. To apply any part of the Trust Fund in acquiring movable/ immovable properties and sell, mortgage, alienate or otherwise dispose off the same as they may think fit and proper.
- c. To take on rent or lease, purchase or construct building and to construct, add, alter demolish, maintain, sell, dispose off, alienate or otherwise deal with any property movable or immovable comprising the Trust Fund, for the achievement of the objects of the Trust.
- d. To let out or lease any movable or immovable property comprised in the Trust Fund such period and at such rent discretion may think fit.
- e. To acquire, purchase, sell, convey, change, transfer transport or otherwise deal with all or any of the investments including shares, stocks, debentures Govt. securities belonging to the Trust or representing the Trust Fund and to re-invest the same as the Trustees may deem fit and proper in accordance with the provisions for income Tax Act.
- f. To apply get registered under sec. 80-G (and also get/apply other relaxation/exemption) of the Income tax Act.
- g. To accept donations, Contributions, gifts and/or other grant-in-Aid either in money or in kind.
- h. To open accounts and give directions to transfer, endorse and sign government securities, promissory notes shares, debentures, securities, instruments etc. and all these accounts shall be operated by the Trustees jointly and/or severally as decided by them but the decision of the Founder, Nominee(s) or The successor (s) shall be final
- i. To appoint sub committees comprising one Trustee or more for carrying out objects and purposes of Trust or matters connected with trust and/or its affairs.




- j. To institute suits, actions and legal proceedings, to prefer appeals, to make applications or petitions and to give affidavits, wherever necessary and to defend or compound, compromise, abandon, submit to arbitration or otherwise settle any suit, action claim, legal proceedings appeal, demand or dispute relating to Trust matters.
- k. To keep proper accounts of the Trust Fund and its proerty.
- l. To apply to whole or any part of the Trust Fund (corpus and/ or income, or property) for the objects and purposes of the Trust and to set apart the whole or part the income of the corpus or part there of for any of the objects of the trust.
- m. To amalgamate the trust with other institutions association, Trust or organisation having public charitable objects and purposes with the consent of two third of trustees in writing.
- n. To nominate, appoint and constitute attorney (s), legal practitioner, agent etc. and to delegate the duties and power vested in them (Trustees) with regard to the management of the Trust Property including starting or de-funding of legal Proceedings or for opening or opening upon accounts with any bank(s), person(s), firm (s) or to do such other act and duties relating to or connected with the Trust Property as may be deemed necessary.
- o. And generally to do all acts, deeds and things as may be necessary for administration of the Trust.
12. The Trustees will not be entitled to receive the remuneration as trustees but may reimburse themselves of all expenses actually incurred by them in connection with trust or their dues there to.
13. Trustees may Iron time to time frame Rules for the conduct of the administration of the trust and regulating the meetings Trustee. In the absence of such regulations.
- (i). All the mailers will be decided by the majority and the quorum for meeting shall be two third.

- (ii). A resolution circulated to all Trust and signed by the majority of such trustees shall be as valid and effectual as resolution duly passed at a meeting of the Trustees.
14. The regular accounts will be maintained relating to all receipts payments, income, expenditure or any properties or liabilities relating to the Trust. Further the accounts of the trust will be audited by a qualified chartered accountant.
15. The Board of Trustees shall be entitled of sue in the name of Trust and may similarly be sued in the name of Trust.
16. All the provisions of Indian trust Act.1882 shall be applicable to this trust.
17. The dissolution of the Trust may be affected by a special Resolution passed by a majority of two third of the Trustees present at the special meeting convened for the purpose and with the consent of the president of the Trust there remain after satisfactions of all its debts and liabilities, any property whatsoever. The same shall not be paid or distributed amongst the Trustees of the Trust, but shall be given or transferred to some other like Institutions "having same aims and objects to be determine" by the Board of Trustees at or before the time of dissolution.
