- 6. Object of the Trust :- The object of the Trust are to:-

- 6.3 Establish, run, develop and management studentship scholarship and render other kind of Aid to studends include supply of books, stipends, medals and other incentives to study without any distinction as to caste colour race creed or sex.
- 6.4 Promote, establish, run and manage institutions for the promontion of science and technology, management, literature, music, drama and fine arts in India for the benefit of the public in general.
- 6.5 Establish, run, maintain and manage for the establishment and / or maintenance of Park, gardens, gymnasium, sports clubs, dharamshalas and rest houses for use by public in general.

- 8. It is hereby declared that no part of the Trust property or its income shall be applied for any purpose other that the objects of Trust as under stood under The Income TaxAct.for the time being in force and the surplus funds if any of the Trust shall be invested as per the provided the Income TaxAct.
- 9. The Number of Trustees shall not be less than three and not more than seven. The Trustees shall be trustees for their life time but any Trustees may resign by giving in writing to the co-Trustees. Appointment of Trustees (s) shall be only with the final approval of settler/his Nominee(s) or the successor(s)
- 10. General Management and control of Trust Properties and its affairs shall be vested Trustees and the Trustees shall have power to do all such acts as may be considered necessary for the benefit of the Trust and managemenet of its properties and affairs veto power shall always remain with settler.nominees or the successor (s)
- 11. All the trustees (including Executive Trustee/Founder)shall from the BORD of TRUSTEES and all the decision shall be taken in the meeting of Board of Trustees called from time to time. Without Prejudice to any of the power that the trustees may have under any for the time being in force or to their general power for managament, the Trustees shall have the following powers also:-

- a. To manage the Trust Fund. Trust Proerty and other affairs relating to Trust and to do all acts,deeds and things necessary for the preservation maintenance and management thereof and the affairs relating there to or connected therewith.including the making of Rules and Regulations from time to time.

- c. To take on rent or lease, purchase or construct building and to construct, add, alter demolish, maintain, sell, dispose off, alienate or otherwise deal with any property movable or immovable comprising the Trust Fund, for the achievment of the objects of the Trust.
- To let our desire any movable or immovable property comprised in the Trust Fund such period and at such rent discrition may think fit.
- e. To acquire perches, very sell convent, change, transfer transport or otherwise deal with all or any of the investments including shares, stocks, debentures Govt. securities belonging to the Trust or representing the Trust Fund and to re-invest the same as the Trustees may deem lit and proper in accordance with the provisions for income TaxAct.
- f. To apply get registered under sec.80-G(and also get/apply other relaxation/exemption) of the Income tax Act.
- g. To accept donations. Contributions, gifts and/or other grantin-Aid either in money or in kind.
- h.
